THE AHWAZI COMMUNITY IS ESTABLISHED TO MEET THE SOCIAL AND CULTURAL NEEDS OF AHWAZIANS. THE COMMUNITY WILL AIM TO:

- PROMOTE THE AHWAZI CULTURE THROUGH SOCIAL ACTIVITIES AND LANGUAGE CLASSES.

- FACILITATE THE MAXIMUM PARTICIPATION OF AHWAZIANS IN THE COMMUNITY.

- PROVIDE AND SOLICIT ASSISTANCE FOR NEEDY FAMILIES, WIDOWS, WIDOWERS, ORPHANS AND OTHER PEOPLE WHOM THE COMMUNITY DEEMS TO BE IN NEED OF SUCH ASSISTANCE.

- FACILITATE ACCESS TO AND INCREASE THE USE OF EXISTING SERVICES.

- TO RAISE THE STANDARD OF WELL-BEING AMONG AHWAZIANS.

- PROMOTE THEIR SMOOTH AND EFFECTIVE ASSIMILATION AND INTERGRATION IN TO THE WIDER COMMUNITY.

POWERS ACTIVITIES:

IN FURTHERANCE OF THE OBJECTS BUT NOT OTHERWISE THE AHWAZI COMMUNITY MAY EXERCISE THE FOLLOWING POWERS:

A- CO- ORDINATE OR ASSISTS IN CO-ORDINATING THE HOLDING OF CULTURAL ENENTS, EXHIBITIONS, MEETINGS, LECTURES, SEMINARS, TRAINING COURSES AND OTHER SOCIAL ACTIVITIES.

B- POWER TO RAISE FUNDS AND TO INVITE AND RECEIVE CONTRIBUTIONS PROVIDED THAT IN RAISING FUNDS THE MANAGEMENT COMMUNITTE SHALL NOT UNDERTAKE ANY SUBSTANTIAL PERMANENT TRADING ACTIVITIES AND SHALL CONFORM TO ANY RELVANT REQUIREMENTS OF THE LAW.

C- POWER TO BUY, TAKE ON LEASE OR IN EXCHANGE ANY PROPERTY NECESSARY FOR THE ACHIEVEMENT OF THE OBJECTS AND TO MAINTAIN AND EQUIP IT FOR USE.

D- POWER SUBJECT TO ANY CONSENT REQUIRED BY LAW TO SELL, LEASE OR DISPOSE OF ALL OR ANY PART OF THE PROPERTY OF THE CHARITY.

E- POWER SUBJECT TO ANY CONSENTS REQUIRED BY LAW TO BORROW MONEY AND TO CHARGE ALL OR ANY PART OF THE PROPERTY OF THE CHARITY WITH REPAYMENT OF THE MONEY SO BORROWED.

F- POWER TO EMPLOY SUCH STAFF (WHO SHALL NOT BE MEMBERS OF THE MANAGEMENT COMMITTEE) AS ARE NECESSARY FOR THE PROPER PURSUIT OF THE OBJECTS AND TO MAKE ALL REASONABLE AND NECESSARY PRONISION FOR THE PAYMENT OF PENSIONS AND SUPERANNUATION FOR STAFF AND THEIR DEPENDANTS.

G- POWER TO CO-OPERATE WITH OTHER CHARITIES, VOLUNTARY BODIES AND STATUTORY AUTHORITIES OPERATING IN FURTHERANCE OF THE BOJECTS OR OF SIMILAR CHARITABLE PURPOSES AND TO EXCHANGE INFORMATION AND ADVICE WITH THEM.  
THE MANAGEMENT COMMITTEE SHALL CONSIST OF NOT LESS THAN FIVE MEMBERS NOT MORE THEN TWELVE MEMBERS BEING.
